Membership Meeting Minutes

March 5, 2024 Membership Meeting
Dalt's American Grill, West Nashville

Joe Moreau called the meeting to order at 6:14 PM. Joe welcomed the members and visitors. He reminded all visitors to please sign in on the peach-colored Visitor sheets so we may and invite you back to future activities and follow up with you about membership.

Joe reviewed upcoming events and available spaces: - March Social @ Firebirds – Wed, Mar 20 or 27; March Day Hike – Sat, Mar 23; April Membership Meeting & Social – Tues, April 2; Overnight Hike @ Mt LeConte – Fri/Sat, May 24/25; Complete details are on the NSC website and in the newsletter. A summary is in the upcoming events flyer.

Joe opened nominations. A slate was presented and the floor was opened to additional nominations or declinations. Nominations were closed with the following candidates: One-year terms for officers 5/1/24 to 4/30/25: Joe Moreau-President; Tom Gormley-Vice President; Jenny Wimsatt-Treasurer; Pete Tuttle-Secretary. He also reviewed the details of the Chamonix 2025 Ski Trip (Mar 8-16, 2025), took questions and announced signups starting online immediately and for 24 hours. He explained the lottery system if the Chamonix trip was oversubscribed. The remaining trips are anticipated to be presented and available for registration at the usual summer kickoff meeting.

Hike: Mt. LeConte

Kick off Memorial Day a bit early by joining us in hiking Mt. LeConte in the Great Smoky Mountains National Park. We recommend you drive up on Thursday so that we can start the hike to the LeConte Lodge on Friday. The Boulevard Trail is a difficult 8-mile hike an elevation gain of 2000 feet. We'll be greeted at the lodge with a cup of coffee or hot chocolate and settle into our bunks for the evening. This is a primitive lodge with no electricity though there are basins for sponge baths. On Saturday we'll hike back down the Alum Cave trail, a difficult 5.5-mile hike with a 1500-foot descent.

We have 13 places in a group cabin. There are 3 rooms, each with a double bunk bed (4 total pillows). Please pre-select a bunkmate although single supplement is available. We will attempt to keep males and females in separate rooms but we may end up with coed rooms.

Brentwood Summer Concert Series - The WannaBeatles Sunday, June 2 - begin gathering 5 PM

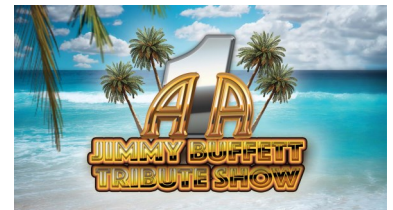
